You want to contribute to a global initiative that will support and uplift the preservation and conservation of ecosystems worldwide?

The objectives of OBC are:

- To define:
 - A standardized approach to quantify positive impacts to biodiversity, ("biodiversity certificate"), based on a recognized measure, which itself is based on a public calculation methodology allowing certification.
 - The rules of an exchange market allowing project holders of ecosystem preservation or restoration projects in protected wild areas to sell biodiversity certificates.
- To carry out complementary actions to these definitions so that companies and other organizations can improve their biodiversity indicators over the long term.

Becoming a member of OBC will allow you to:

- Take part in the design and implementation of biodiversity certificates, an international mechanism for the financing of biodiversity action based on an open-source methodology.
- In addition, you will:
 - Be informed of the progress of work and news on the subject.
 - Have the opportunity to participate to working groups that are relevant to your activity.
 - Have access to the consortium internal resources and bibliography.
 - Develop your network and expertise thanks to:
 - A participation to the OBC General assembly and communication events
 - Regular exchanges with other OBC members
